

Guidelines for Campus Entrepreneurial Team Company Establishment, Registration, and Residency at Chung Yuan Christian University

Approved at the 105th-4th Industry-Academia Cooperation Steering Committee Meeting on July 4, 2017
Amended at the 107th-1st Industry-Academia Cooperation Steering Committee Meeting on November 2, 2018

- Article 1. In alignment with the Ministry of Education's initiative to encourage universities to utilize their campuses as venues for faculty and students to establish and register innovative businesses and companies, the "Guidelines for Campus Entrepreneurial Team Company Establishment, Registration, and Residency at Chung Yuan Christian University" (hereinafter referred to as "the Guidelines") have been formulated in accordance with the "Implementation Measures for Chung Yuan Christian University's Spinoffs."
- Article 2. Campus Entrepreneurial Teams must fully meet the following eligibility requirements to apply for registration at the University:
- (a) The team members must include full-time faculty, staff, workers, current students, or alumni who have graduated within the last five years.
 - (b) The campus entrepreneurial team must be registering for the first time and have been approved by the Spinoffs Development Committee.
 - (c) The establishment of the company must contribute to the enhancement of the University's teaching and research functions as follows:
 1. The establishment of the company will strengthen the link between industry and academia, providing opportunities for the University to offer teaching and internship training.
 2. The company will assist in the commercialization of the University's R&D results and technology transfer, contributing to industrial innovation, the research outcomes should be supported by industry-academia collaborative research or academic publications.
- Article 3. The application for the establishment and registration of the Campus Entrepreneurial Team Company will undergo a two-stage review process at the University:
- (a) Application Stage: The application form for the establishment and registration of the entrepreneurial team on campus will be submitted to the Spinoffs Development Committee of Chung Yuan Christian University for review.
 - (b) Examination Stage: Following the review, the application for registration will be forwarded to the Ministry of Education for further examination.
- Article 4. The registration period for campus entrepreneurial team companies on campus is generally three years, with a maximum extension of two additional years.
- Article 5. Matters not covered in these guidelines will be handled following the "Ministry of Education's Criteria for Examining and Registering Entrepreneurial Teams Establishing Companies on Campus," the "Implementation Measures for Chung Yuan Christian University's Spinoffs," and the "Critical Points for the Management of Fees and Usage of the Chung Yuan Christian University Industry Accelerator and Incubation Center for Resident Companies."

Article 6. These guidelines have been approved by the Industry-Academic Cooperation Steering Committee and will be implemented after approval by the principal. These guidelines have been approved by the Industry-Academia Cooperation Steering Committee and shall be promulgated and enforced by the President. The same shall apply when the guidelines are amended.
